Operating Permits issued pursuant to § 3.62 (c) are issued with authorization to drill, complete, and operate a new, non-exempt well proposed to produce 10 acre-feet of water per year or less, or that will have a maximum capacity of 50 gallons per minute or less, may be issued as a single permit, in the form of an Operating Permit.

The Board is proposing to adopt a Drought Management Plan for the purpose to conserve, preserve, protect, and recharge the groundwater resources of Burnet County, and to prevent waste and degradation of quality of those groundwater resources.

Provisions of the plan shall apply to all Burnet County wells and all persons or organizations, public or private, owning or operating wells within Burnet County, regardless of purpose of use, size, capacity, date drilled, ownership, or the exempt or non-exempt status of a well.

This Drought Management Plan will rely primarily on voluntary compliance, except where otherwise noted for permitted users in drought stages 3 and 4. The District encourages the voluntary reduction measures outlined in this plan to achieve a desired level of conservation and reduced impact to the aquifers. However, this section does not exclude the District from exercising authority of its civil penalties policy in the District's Rules regarding wasteful use of water. The plan does recognize existing drought management plans by public water supply systems and voluntary water conservation efforts of other individual permit holders.
